VIRGINIA LOTTERY'S \$50,000,000 REDSKINS MANIA OFFICIAL SWEEPSTAKES RULES

- A. PURPOSE:** A Sweepstakes ("Sweepstakes") will be conducted to support the Virginia Lottery's \$20 "\$50,000,000 REDSKINS MANIA" scratcher game. Nine (9) drawings ("Prize Drawings") will be conducted with this Sweepstakes. Drawings will be conducted to award Tickets to Redskins games, Redskins Gift Cards, Redskins Jerseys, Redskins Helmets and Redskins Experience Prizes.
- B. SWEEPSTAKES PERIOD:** The Sweepstakes will be conducted beginning on Monday, August 3, 2009, and ending on Thursday, March 25, 2010 ("Sweepstakes Period"). In conjunction with this Sweepstakes, nine (9) prize drawings will take place, one (1) each on Friday, August 28, 2009, Friday, September 11, 2009, Friday, September 25, 2009, Friday, October 9, 2009, Friday, October 23, 2009, Friday, November 6, 2009, Friday, November 20, 2009, Friday, December 4, 2009 and Friday, March 26, 2010, to select the winners for this Sweepstakes.
- C. SWEEPSTAKES ENTRY:** To participate, a player must submit a \$20 non-winning Virginia Lottery \$50,000,000 REDSKINS MANIA scratcher ticket via an established entry method for this Sweepstakes. Entries for this Sweepstakes will be accepted via US mail and the internet.
- D. ENTRY DEADLINES:** All mailed Sweepstakes entries must be received at the Lottery Contest P.O. Box # 1758 by Thursday, August 27, 2009, in order to be eligible to participate in the Friday, August 28, 2009 drawing. Entries received from Friday, August 28, 2009 through Thursday, September 10, 2009 will be eligible to participate in the Friday, September 11, 2009 drawing. Entries received from Friday, September 11, 2009 through Thursday, September 24, 2009 will be eligible to participate in the Friday, September 25, 2009 drawing. Entries received from Friday, September 25, 2009 through Thursday, October 8, 2009 will be eligible to participate in the Friday, October 9, 2009 drawing. Entries received from Friday, October 9, 2009 through Thursday, October 22, 2009 will be eligible to participate in the Friday, October 23, 2009 drawing. Entries received from Friday, October 23, 2009 through Thursday, November 5, 2009 will be eligible to participate in the Friday, November 6, 2009 drawing. Entries received from Friday, November 6, 2009 through Thursday, November 19, 2009 will be eligible to participate in the Friday, November 20, 2009 drawing. Entries received from Friday, November 20, 2009 through Thursday, December 3, 2009 will be eligible to

participate in the Friday, December 4, 2009 drawing. Entries received from Friday, December 4, 2009 through Thursday, March 25, 2010 will be eligible to participate in the Friday, March 26, 2010 drawing.

Internet entries will be accepted until 11:59 p.m. on Thursday, August 27, 2009 for the Friday, August 28, 2009 drawing, until 11:59 p.m. on Thursday, September 10, 2009 for the Friday, September 11, 2009 drawing, until 11:59 p.m. on Thursday, September 24, 2009 for the Friday, September 25, 2009 drawing, until 11:59 p.m. on Thursday, October 8, 2009 for the Friday, October 9, 2009 drawing, until 11:59 p.m. on Thursday, October 22, 2009 for the Friday, October 23, 2009 drawing, until 11:59 p.m. on Thursday, November 5, 2009 for the Friday, November 6, 2009 drawing, until 11:59 p.m. on Thursday, November 19, 2009 for the Friday, November 20, 2009 drawing, until 11:59 p.m. on Thursday, December 3, 2009 for the Friday, December 4, 2009 drawing and until 11:59 p.m. on Thursday, March 25, 2010 for the Friday, March 26, 2010 drawing. Entries received but not selected to win a prize in a drawing will not be eligible for next drawing.

E. MAILED ENTRIES:

1. To enter by mail, a player must **clearly** and **legibly print** his or her full name (first, middle initial & last), date of birth, street address, city, state, zip code and daytime telephone number on the back of their non-winning Virginia Lottery \$50,000,000 REDSKINS MANIA scratcher ticket submitted as their Sweepstakes entry (An address stamp or pre-addressed label may be used). The Player must include their date of birth when using an address stamp or pre-addressed label to provide proof of age. The non-winning ticket must be mailed in an envelope no larger than 4½" x 9 ½" during the Sweepstakes Period, to the Sweepstakes address:

- Entries will not be accepted that are mailed to or delivered to any other Virginia Lottery address.
2. Only one (1) name may be recorded on a non-winning ticket. In the event that more than one (1) name is recorded on a ticket, the first name shall be deemed to be, and for all purposes regarded as, the entrant.
 3. Entries mailed to the Virginia Lottery with insufficient postage will be deemed invalid.
 4. Mailed entries will not be opened unless the entry is selected as a winner during one of the Grand Prize drawings. Multiple entries enclosed in one envelope will be disqualified.

F. INTERNET ENTRIES:

1. To enter via the Internet, a player must go to the Virginia Lottery's contest website at www.valottery.com/redskins, access the Sweepstakes page and enter his or her full name (first, middle initial and last), date of birth, street address, city, state, zip code, daytime telephone number and e-mail address. The player must follow the web page instructions for entering the validation numbers found on the back of his/her non-winning Virginia Lottery \$50,000,000 REDSKINS MANIA scratcher ticket.
2. All non-winning tickets whose numbers are submitted via the Internet as a Sweepstakes Entry **must be retained**. A player will be required to submit his/her non-winning ticket to the Virginia Lottery or its designee if his/her entry is selected as a winner for a drawing.
3. Players must correctly enter the validation number found on the back of their non-winning scratcher ticket. The Virginia Lottery will not be responsible for validation numbers that are transposed or entered incorrectly.

G. ELIGIBILITY:

1. Only non-winning Virginia Lottery \$50,000,000 REDSKINS MANIA scratcher tickets will be accepted as valid entries for this Sweepstakes. For the purposes of this Sweepstakes, a "non-winning ticket" is defined as a ticket, purchased at a licensed Virginia Lottery retailer location or directly from the Virginia Lottery, which does not have a winning prize combination.
2. Each non-winning ticket used for this Sweepstakes must have been issued by the Virginia Lottery in an authorized manner during the Sweepstakes Period, must be intact and must not be mutilated, altered, reconstituted or tampered with in any manner.
3. This Sweepstakes is open to players eighteen (18) years of age or older. Players will be required to provide proof of their date of birth.
4. Board Members, officers, employees and vendors of the Virginia Lottery and any person(s) residing in the same household of such member, officer, employee or vendor are not eligible to participate in this Sweepstakes.
5. A player may enter the Sweepstakes more than once as long as a different non-winning \$50,000,000 REDSKINS MANIA scratcher ticket is submitted with each

- entry. However, a player is only eligible to win one (1) prize per drawing as a result of this Sweepstakes.
6. The Virginia Lottery will not be responsible for entries submitted incorrectly, received before the Monday, August 3, 2009 start date, or received after the Thursday, March 25, 2010 entry deadline date. Such entries shall be deemed invalid.
 7. Only entries that are submitted in the manner described in Section E (“Mailed Entries”) and Section F (“Internet Entries”) of these official rules will be eligible for entry in this Sweepstakes. Hand-delivered entries will not be accepted for this Sweepstakes and will be deemed invalid.
 8. Persons must correctly enter his or her personal information. The Virginia Lottery will not be responsible for information that is entered incorrectly.
 9. Each entry must contain current and valid information. The Virginia Lottery will not change or update entry information for an entry that has already been submitted.
 10. Prize winners who have their Winner Notification Letter returned undeliverable due to blocked e-mails, incorrect address information, or expired forwarding address notifications will forfeit their opportunity to win a prize. Neither the Virginia Lottery nor its designee will be required to attempt delivery of a Winner Notification Letter more than once.
 11. Virginia Lottery prizes awarded during this Sweepstakes are not transferable or assignable. Redskins Ticket, Experience Prizes, Gift Cards or Merchandise Prizes are not redeemable for cash.
 12. Each Sweepstakes winner may be required to participate in publicity efforts. Examples include an interview with television, radio and/or newspaper reporters and/or photographers or cameramen. This information may be used in future Sweepstakes media and/or on the Virginia Lottery’s Web Page without additional consent or compensation to the winner.

H. SWEEPSTAKES DRAWINGS: On Friday, August 28, 2009, Friday, September 11, 2009, Friday, September 25, 2009, Friday, October 9, 2009, Friday, October 23, 2009, Friday, November 6, 2009, Friday, November 20, 2009, Friday, December 4, 2009 and Friday, March 26, 2010, the nine (9) established drawing dates for the Virginia Lottery’s \$50,000,000 REDSKINS MANIA Sweepstakes, a drawing will be conducted from all eligible entries submitted via the established entry methods and by the established entry deadline date. The following is an overview of how the entries will be randomly selected for this Sweepstakes.

1. After the established entry deadline date, but prior to the drawings, all entries submitted for that drawing will be accounted for and the information loaded into a randomizer program.

2. Representatives from the Virginia Lottery's Marketing Department along with a representative from the Virginia Lottery's Security Department will oversee the use of the randomizer program to select the winning entries for this Sweepstakes.
3. Winners of sweepstakes prizes will be randomly selected. Prizes will be assigned in a specific order, from highest value first (Redskins season tickets for twenty (20) years) to lowest value last. The order in which the winning entries are drawn shall be recorded by Virginia Lottery officials; the Lottery's decision shall be final and controlling.
4. Immediately after the winners are selected, one hundred (100) alternate entries for each drawing will also be selected using the same randomizer program. All alternate entries will be recorded in the order in which they were selected, and will be used should any Prize winner be determined ineligible.
5. After each Drawing is completed, a representative of the Virginia Lottery's Security Department along with a representative of the Marketing Department will confirm that the entries selected in the drawing are valid. In the event that a selected entry is deemed invalid (see section G "Eligibility"), the first alternate with a valid entry will be selected as a winner. This process shall continue until all valid winning entries have been selected.
6. A representative of the Virginia Lottery's Security Department will confirm the drawings and officially award prizes to the winners and finalists selected.
7. Winners and Finalists for this Sweepstakes will be notified in writing or via e-mail of their winning status. Winners who fail to respond to their winner notification within ten (10) calendar days from the date of notification will forfeit their Prize.

I. REDSKINS PRIZE DESCRIPTION: In association with this Sweepstakes, nine (9) drawings will be conducted to award the following prizes. The \$50,000,000 REDSKINS MAINA Sweepstakes winners will be determined in the manner described above in Section H.

The Virginia Lottery or its designee will contribute \$3,800.00 toward the state and federal tax on the winner's behalf for the prize. Each winner will be responsible for any additional taxes owed as a result of winning a prize in this Sweepstakes. The total prize value (including the taxes contributed on the winner's behalf) is \$13,700.00, and will be reported to both the Internal Revenue Service and Virginia Department of Taxation.

One (1) catered luxury suite for up to twenty (20) people, six (6) purple parking passes and \$1,000 in spending money. Good for one (1) predetermined home game at FedEx Field during the 2009 season. The Virginia Lottery or its designee will contribute \$8,000.00 toward the state and federal tax on the winner's behalf for the prize. Each winner will be responsible for any additional taxes owed as a result of winning a prize in this Sweepstakes. The total prize value (including the taxes contributed on the winner's behalf) is \$29,000.00, and will be reported to both the Internal Revenue Service and Virginia Department of Taxation.

VIP Fly-Away with the Team to Dallas:

Round-trip travel on the team plane, local travel on the team bus, hotel accommodations in the team hotel and two (2) tickets to the game. Each winner can bring one (1) guest (at least eighteen (18) years old) and will receive \$1,000 in spending money. The

Virginia Lottery or its designee will contribute \$4,200.00 toward the state and federal tax on the winner's behalf for the prize. Each winner will be responsible for any additional taxes owed as a result of winning a prize in this Sweepstakes. The total prize value (including the taxes contributed on the winner's behalf) is \$15,200.00, and will be reported to both the Internal Revenue Service and Virginia Department of Taxation.

VIP Tour of Redskins Park

Each winner may bring one (1) guest (at least eighteen (18) years old)

\$500 spending money

The prize value is \$3,000.00, and will be reported to both the Internal Revenue Service and Virginia Department of Taxation

Game-Used Jerseys:

One (1) authentic game-used jersey signed by a Redskins player.

The prize value is \$1,000.00, and will be reported to both the Internal Revenue Service and Virginia Department of Taxation

How the VIP trips to Dallas will be awarded:

Ten (10) VIP trips to Dallas will be given away during an on-field halftime event at the Monday, October 26, 2009 Eagles game. Twelve (12) entry finalists (plus one (1) guest each) will be brought to the game, sit in Club Seat A section, receive \$500 in spending money and come on field during halftime. At this time ten (10) finalists will win the VIP trip to Dallas. The two (2) entry finalists who do not win will receive four (4) tickets to the Sunday, December 27, 2009 Redskins vs. Cowboys game (club seats in the A section) and \$1,000 in spending money. All participants in the on-field event will receive overnight lodging after the game.

How the season tickets for 20 years will be awarded:

Seven (7) pairs of season tickets for twenty (20) years will be given away during an on-field halftime event at the Monday, December 21, 2009 Giants game. Sixteen (16) entry finalists (plus one (1) guest each) will be brought to the game, sit in Club Seat A section, receive \$500 in spending money and come on field during halftime. At this time seven (7) participants will win the season tickets for twenty (20) years. The nine (9) entry finalists who do not win will receive one (1) pair of season tickets for the 2010 season. All participants in the on-field event will receive overnight lodging after the game.

In the event of decline of prize(s):

In the event one or more winners of the seven (7) season tickets for twenty (20) years declines to accept the prize(s), the Executive Director, at her sole discretion, may add such prize or prizes to the prizes available in the March 26, 2010 drawing and make such adjustments to the procedures for drawing and awarding the prizes available in the March 26, 2010 drawing as may be reasonably necessary.

The March 26, 2010 drawing shall be conducted and winners determined in the manner described above in Section H.

J. WINNER PROCEDURES:

1. The \$50,000,000 REDSKINS MANIA Winners selected in association with this Sweepstakes will each be notified by an official letter sent by the Virginia Lottery. Included with the congratulatory letter will be a Claim form and an Affidavit of Eligibility form.
2. Each \$50,000,000 REDSKINS MANIA Prize Winner will be required to complete the forms attached to their congratulatory email or included in his or her congratulatory information packet and returns the completed forms by the deadline date stated in the congratulatory letter.

K. PRELIMINARY WINNER DRAWINGS: In association with this Sweepstakes, special drawings will be conducted between Friday, August 28, 2009 and Friday, December 4, 2009. These drawings will award Sweepstakes entrants the opportunity to participate in on-field prize giveaway contests conducted at FedEx Field in Landover, Maryland. The contest will be conducted during the half times of Washington Redskins football games played on Monday, October 26, 2009 and Monday, December 21, 2009.

A total of twelve (12) winners will be selected to participate in the Monday, October 26, 2009 on-field contest and sixteen (16) winners will be selected to participate in the Monday, December 21, 2009 on-field contest. L. PRELIMINARY WINNER PROCEDURES: Due to the special nature of the on-field contests conducted at FedEx Field on Monday, October 26, 2009 and Monday, December 21, 2009, these Preliminary winners will be required to follow the procedures listed below.

The designated Preliminary winners selected in the various drawings listed in Section K of these rules will be notified by an official letter sent by the Virginia Lottery via United Parcel Service (“UPS”). Included with the congratulatory letter will be a Claim form, an Affidavit of Eligibility form, a pre-paid, pre-addressed UPS return envelope, and a complete copy of the Virginia Lottery’s \$50,000,000 Redskins Mania Official Sweepstakes Rules.
2. Internet winners will also receive information on the “\$50,000,000 Redskins Mania” scratcher ticket they submitted as their winning entry and will need to submit in order to participate in any on-field contest giveaways.
3.
